\_\_\_\_\_ (initial) I have read and agree to the Hutch's Tricycle Race Rules.

- I will ride my tricycle safely, and will be courteous to all competitors.
- I will remain seated in the tricycle seat at all times.
- I will pedal with my feet on the pedals or straddling the trike with feet on ground (duck-walk). Hands must be on the handlebars at all times.
- Riders are required to wear a helmet. No exceptions.
- All wheels of the tricycle must remain in contact with the ground during the race, with the exception of the rider tipping over.
- No tricycle or lane assignments. There will be a 'dash' to 'claim' tricycle.
- Each heat winner will compete for top tricyclist.
- Good sportsmanship is required and judges have the right to disqualify any person for intentional contact or displaying unacceptable behavior.

## Waiver and Release of Liability

In consideration of being permitted to participate in the **Humane Society of Central Oregon's ("HSCO") Hutch's Oktoberfest Tricycle** Race (the "Event"), I, intending to be legally bound for myself, my heirs, executors and administrators, do hereby **waive**, **release**, **and forever discharge** HSCO, including any director, officer, employee, volunteer, representative, agent, subsidiary, affiliate, partnership, limited liability company, or joint venture thereof, any Event sponsor, and any of their successors or assigns (together, the "Released Parties"), from any and all liabilities, claims, demands, proceedings, actions, or causes of action, liabilities, expenses, or damages of every kind and nature whatsoever, whether known or unknown, including but not limited to reasonable attorneys' fees and costs, arising from or in any way related to my attendance at or participation in the Event, whether the result of negligence or any other cause.

Further, I hereby indemnify, defend, and hold harmless the Released Parties from any and all liabilities or claims made by other individuals or entities arising from or in any way related my attendance at or participation in the Event.

I understand that there are inherent risks and dangers associated with attending or participating in the Event, which may result in illness, personal injury, property damage, property theft, permanent disability or death. I hereby assume all of the risks of participating in or attending the Event, whether known or unknown. I acknowledge that I assume full responsibility for my safety. I agree that the Released Parties do not assume any liability or responsibility whatsoever for any harm, injury, personally injury, illness, or damage caused by myself.

I understand that I may be photographed at the Event and allow HSCO or any Event sponsor to use my name and likeness of me for any legitimate purpose without obligation or liability to me.

This Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the fullest extent permitted under applicable law and that if any portion hereof is later found to be invalid or unenforceable, the balance of this Waiver and Release of Liability shall continue in full force and effect. I hereby certify that I have read this Waiver and Release of Liability and the rules of the Event attached hereto and I understand the content and agree to abide by the rules.
